## **Denmark Receives Road Safety PIN Award 2013**

Road Deaths Cut by 31% in Denmark since 2010

17 June 2013, Brussels – "I am honoured to welcome Denmark as the latest entry in our prestigious list of PIN¹ Award recipients. Their achievements in reducing the number of deaths on Danish roads make Denmark worthy of being recognised as a road safety champion," said Antonio Avenoso, ETSC² Executive Director at the PIN Award Ceremony held during the 7<sup>th</sup> Annual Conference of the Road Safety Performance Index (PIN) Project. The Award for Denmark was presented to the Justice Minister Morten Bødskov.

Since 2001, Denmark has achieved an impressive 59% reduction in the number of road deaths, the fourth best in the EU.<sup>3</sup> Moreover, Denmark is a frontrunner in terms of progress towards the EU road safety target of halving road deaths between 2010 and 2020, and has reached a road mortality figure of 31 deaths per million inhabitants.<sup>4</sup> "We are confident that this Award, coming as Denmark reached its domestic target of having less than 200 road deaths, will spur efforts of all Danish stakeholders to continue on this path and do even better in the future," added Mr. Avenoso.


In his speech, Mr. Bødskov detailed the policies which helped his country improve road safety, particularly focusing on actions to tackle drink driving and speeding. He acknowledged that, despite current efforts, full compliance with speed limits and drink driving legislation has yet to be reached, hence work on these, as well as other emerging causes of risk on the roads, should remain high on the policy-makers' agenda. "As the relation between speed and the risk and severity of consequences following collisions has been well-documented, we believe it is important to focus on the consequences and risk of speed, even when the speeding is not excessive," he said. Additionally, Mr. Bødskov identified lack of attention by road users as an emerging area of concern which will need to be addressed in the future.


He also noted that one of the priorities in the new Danish Road Safety Strategy, adopted in April 2013 to cover the period up to and including 2020, is the use of hospital data to minimise the underreporting of serious injuries. Finally, he stressed the importance of all countries having comparable data on serious injuries and said that Denmark will hopefully be able to provide data based on the Maximum Abbreviated Injury Scale from 2015 onwards.<sup>5</sup>


