## European drivers keen on enforcement

Three in four European drivers (76%) are "in favour" or "strongly in favour" of more police enforcement, according to the latest SARTRE survey<sup>1</sup> published last week. Drivers support enhanced efforts especially in those countries where levels of enforcement are low (e.g. Italy, Ireland).

The European Transport Safety Council launches today a new publication 'Enforcement Monitor' reporting on progress in a first set of 6 countries, including safer countries such as Sweden, Denmark and Finland as well as countries with a higher road risk such as Hungary, France and Belgium.

With its Enforcement Monitor, ETSC will keep a close eye on how different Member States implement the European Commission's Recommendation<sup>2</sup> on the enforcement of speed, alcohol and seat belt legislation. The 'Monitor' is part of a larger Enforcement Programme, started in September this year, in which ETSC also promotes compliance enhancing vehicle technologies such as speed limiters, alcohol interlocks and seat belt reminders, as well as the safer roads to curb speeds.

Especially striking progress has been made by France, which has seen a dramatic increase in compliance with speed limits, alcohol and seat belt regulation mainly through improved police checks, in combination with increased penalties and public awareness. The results show that in 2003, 1.597 lives were saved, 173 through increased seat belt use alone.

" European drivers are aware of the benefits of enforcement, and governments mustn't be shy to increase checks. Recent experience in France has shown that measures can be highly effective if they are well explained and publicised," said Jörg Beckmann, ETSC's Executive Director.
